## LOWER ELWHA KLALLAM TRIBE Troll Regulations-Western Strait of Juan de Fuca F18-009

The following regulation is promulgated by the Lower Elwha Klallam Tribe and shall govern the conduct of off-reservation commercial and subsistence troll fisheries in the areas and times outlined below.

## 1. FISHING AREAS

Commercial salmon catch reporting areas 4B 5,6,6c

## 2. EFFECTIVE DATES

May 1, 2018 through April 30, 2019

## 3. LAWFUL GEAR

- A. Hand lines: Maximum 2 single or 1 treble hook per line; all hooks must be barbless. Maximum of two lines per fisher.
- B. Salmon troll gear: Maximum of 8 lines per vessel; maximum of 72 hooks per vessel. All hooks must be barbless.

## 4. TIMES AND AREAS OF OPENINGS

Days and Times

Fishing shall be permitted at all hours of each day during each of the following open periods:

#### Area 4B:

Open for chinook only, from 5/1/18 through the earliest of 6/30/18 or reaching a Treaty ocean fishery sub-quota of 20,000 Chinook.

Open for all species except coho and chum salmon and steelhead, from 7/1/18 through the earliest of 9/15/18, or reaching a Treaty ocean fishery sub-quota of 20,000 Chinook. Coho, chum, and steelhead must be released unharmed. Chinook salmon measuring less than 24" must be released unharmed.

Area 5,6,6c:

Closed for all salmon species 5/1/18 through 6/15/18. Open for all salmon species 6/16/18/through 9/30/18, except chum salmon Must be released; subject to the area and catch restrictions outlined below.

All areas:

Closed for all species 10/01/18 to 10/31/18.

Open 11/01/18 through 4/15/19 except close if chinook catch reaches the Preseason established harvest guidelines of 8,500; subject of the area and catch restrictions outlined below.

#### 5. AREA RESTRICTIONS

Troll gear must not be operated closer than 1,000 feet away from any stream or river mouth.

#### 6. TAKE-HOME SUBSISTENCE CATCH

During commercial troll fisheries, no more than two (2) undersize chinook salmon, per fisher, may be kept daily for take-home subsistence purposes.

#### 7. EMERGENCY REGULATIONS

These regulations may be modified at any time by emergency regulations.

#### 8. AUTHORITY

This regulation is promulgated by the Lower Elwha Klallam Fisheries Manager under authority specified by the Lower Elwha Klallam Fishing Ordinance Third Edition.
