OTHER RESTRICTIONS: AS PER REG. #S19-016, ADDITIONALLY:

1. SHRIMP POTS: THE MAXIMUM TOTAL NUMBER OF POTS AND/OR RING NETS COMBINED WILL BE 3 POTS. SHRIMP POTS REGISTERED TO A PARTICULAR VESSEL MUST BE SET AND PULLED BY THAT VESSEL, UNLESS OTHERWISE APPROVED BY THE FISHERIES OFFICE. OVERNIGHT SOAKS ARE NOT PERMITTED. ALL POTS MUST BE PULLED FROM THE WATER BY SUNSET EACH DAY.

2. ALL POTS AND RING NETS SHALL HAVE BUOYS ATTACHED. BUOYS MAY BE ANY COLOR EXCEPT YELLOW OR ANY COMBINATION OF RED AND WHITE. BUOYS MUST REMAIN FLOATING AT ALL TIMES EXCEPT DURING EXTREME TIDES.

BUOYS WILL ALSO BE MARKED WITH THE TRIBE'S INITIALS AND WITH THE FISHER'S ID NUMBER. BUOY LINES WILL BE WEIGHTED TO KEEP THE LINES FROM FLOATING.

- 3. THE DAILY SUBSISTENCE HARVEST LIMIT IS 20 LBS PER FISHER. AND 40 POUNDS PER BOAT.
 - AND RECORDED ON SUBSISTENCE CARD PRIOR TO LEAVING THE HARVEST AREA. AND MUST BE REPORTED TO THE RESPECTIVE TRIBAL FISHERIES OFFICE WITHIN 24 HOURS FOLLOWING THE SUSISTENCE FISHERY.
- 4. ALL FISHERS MUST BE PREPARED TO HAUL OUT ANY REFUSE CREATED BY THEIR OWN ACTIONS DURING AND IMMEDIATELY AFTER THE FISHERY. REFUSE DISPOSAL FACILITIES MAY BE LIMITED IN CERTAIN AREAS OF HOOD CANAL.

JUSTIFICATION: THIS REGULATION RESTORES THE 400LBS HARVEST LIMIT.
