DAYS/HOURS: THE FISHERY WILL OPEN TUESDAY  
MAY 18TH AND CONTINUE THROUGH  
TUESDAY JUNE 30TH PROVIDED  
THAT THE FISHERY FOR EACH TRIBE  
MAY CLOSE SOONER IF THE INDIVIDUAL  
TRIBAL TARGET HARVEST IS TAKEN  
PRIOR TO THIS DATE.

DAILY OPENING WILL OCCUR FROM  
SUNRISE TO SUNSET EACH DAY.

OTHER RESTRICTIONS: AS PER REG. #S21-014, ADDITIONALLY:

1. SHRIMP POTS: THE MAXIMUM TOTAL NUMBER OF POTS AND/OR RING NETS COMBINED WILL BE 3 POTS. SHRIMP POTS REGISTERED TO A PARTICULAR VESSEL MUST BE SET AND PULLED BY THAT VESSEL, UNLESS OTHERWISE APPROVED BY THE FISHERIES OFFICE.
2. ALL POTS AND RING NETS SHALL HAVE BUOYS ATTACHED. BUOYS MAY BE ANY COLOR EXCEPT YELLOW OR ANY COMBINATION OF RED AND WHITE. BUOYS MUST REMAIN FLOATING AT ALL TIMES EXCEPT DURING EXTREME TIDES.  
BUOYS WILL ALSO BE MARKED WITH THE TRIBE'S INITIALS AND WITH THE FISHER'S ID NUMBER. BUOY LINES WILL BE WEIGHTED TO KEEP THE LINES FROM FLOATING.
3. THE DAILY SUBSISTENCE HARVEST LIMIT IS 20 LBS PER FISHER. AND 40 POUNDS PER BOAT.  
AND RECORDED ON SUBSISTENCE CARD PRIOR TO LEAVING THE HARVEST AREA.
4. ALL FISHERS MUST BE PREPARED TO HAUL OUT ANY REFUSE CREATED BY THEIR OWN ACTIONS DURING AND IMMEDIATELY AFTER THE FISHERY. REFUSE DISPOSAL FACILITIES MAY BE LIMITED IN CERTAIN AREAS OF HOOD CANAL.

HARVEST RESTRICTIONS:

- 1) THE TOTAL TRIBAL HARVEST  
FOR AREA 27A AND 27B IS 500LBS FOR BOTH  
AREAS COMBINED.

JUSTIFICATION: HARVEST 500 LBS SUBSISTENCE QUOTA.
