#### Tribal Operations/Public Health Office Update—Tia Skerbeck

## Hello everyone! Just a few updates on things that have been going on during this past month, and some COVID updates:

#### PHASE 3.5

On June 29th, resolution 80-21 was approved which moved the Tribe into Phase 3.5 of the reopening plan. This phase allows for vaccinated people to no longer wear masks (with exceptions for health department staff, and staff that work with populations that are not eligible for the COVID-19 vaccine (kids and infants)), larger group sizes indoors (40), and unlimited groups size outdoors. The CDC's guidelines for travel should be followed.

#### FREEZERS

Freezers are finally starting to be delivered! The freezers have started to ship from the manufacturer, and the appliance company has started to install. The process of receiving and installing the freezers will span many weeks, but we're starting to see the light at the end of the tunnel and should all have our freezers in our homes soon.

#### **COVID CASES**

COVID cases have been staying low for our community, with zero in the past 3 weeks. Keep up the great work, continue to stay home when sick, and get your vaccination if you haven't already

#### VACCINES

Currently the Health Department is scheduling COVID vaccinations for the Moderna, Johnson & Johnson, and Pfizer vaccines. Youth aged 12-17 are now eligible for the Pfizer vaccine and will need a guardian to accompany them to their appointment. To schedule your COVID vaccine, call the clinic at 360-452-6252. Community vaccine clinics are still taking place periodically in the Tribal gym, call the clinic for more information.

#### VACCINE SUPPORT PROGRAM

The Youth and Adult COVID-19 vaccine support program is under way, with promotional items ranging from \$200 gift cards to \$400 checks. To participate you must be fully vaccinated, meet the eligibility criteria, and apply online. Limited paper applications are available at the Tribal Center, and Social Services. Assistance completing the application is available, just call me at 360-452-8471 x7420.

## Summer Safety Tips

## Be Sun Savvy

- Use a broad-spectrum sunscreen with an SPF of at least 15.
- Wear a hat, sunglasses (with UV protection) and lightweight, light-colored clothing.
- Seek shade under a tree, shelter or an umbrella.
- Wear a protective sun shirt in the water.

## Be a Water Watcher

- Never take your eyes off of children in a pool or any body of water, even for a moment!
- If you're in a group, appoint a designated "water watcher," taking turns with other adults.
- Avoid distractions like your phone, books or magazines.
- Use caution with water wings or other inflatable toys.

## Don't Get Bugged

- Wear an insect repellant with at least 20% DEET.
- Cover exposed skin with long-sleeved shirts, long pants and hats.
- If you've been in the woods, check your kids, your pets and yourself for ticks.
- Stay inside at dusk and dawn, the most active times for bugs.
- Avoid places with standing water, which attracts mosquitoes.

## Hot Car Reminder

- Never leave a child or a pet inside a parked car, even for a minute.
- If you're not used to having a child in your car, put something you will need next to the car seat, such as a briefcase, purse or cell phone.
- If you see a child alone in a car, call 911 immediately.

#### Letter to the Community-LaTrisha Suggs



## Tribal Member LaTrisha Suggs (Cook-Kardonsky Family) Running as Incumbent for City of Port Angeles Council Position 1

The "Vote 4 Suggs" campaign and Primary election season is underway. I currently serve on the Port Angeles City Council, position 1. I completed the 2 yrs. that remained on the vacant seat when I was appointed to the seat back in 2020. I am the first enrolled Native American to sit on the Council for City of Port Angeles since it was formed. I am honored and humbled to represent the citizens of Port Ange-

les while honoring and representing the spirit of our ancestors. Since the election of 2019 diversity has been pushed into the spotlight. Diversity has been long overdue on the city of Port Angeles council. Native and non-native communities collided in the 17th century with the local superintendent being the voice for Native Communities. Today times have changed, we are more involved at the Federal and State representative level, and now Tribal citizens are engaged in local elections.

I am seeking re-election support from residents of Port Angeles. I know that we have a lot of Klallam Tribal citizens that live in the area, and I ask for your support. It is vital that all citizens participate in the primary election and the general election. It is vital that all registered voters vote. Please encourage your family and friends to get out and vote in both the primary and the general elections. I have two challengers, which places me in the primary election. My goal is to make it to the General election. Your vote is vital, as has been evidenced in the local 2016 election when one Port Angeles city council position was won by ONE vote.

I graduated from Port Angeles High School in 1989, attended Peninsula College, and obtained my Bachelor of Environmental Policy/Planning from Western Washington University/Huxley Program. Accumulated 300 hours of Federal Acquisition Regulation Training and a Municipal Leadership Certificate. I serve on the Port Angeles Shore Memorial Pool District as a board member, Solid Waste Advisory Committee, and the Marine Resources committee for the City. For the Tribe I serve on the Jamestown Economic Development Authority Board, Health Committee, Cannabis Board, and recently appointed to the Washington Water Trust board.

I have lived in Port Angeles most of my life. I have three fabulous kids (Austin Suggs, Zelby Gloria, and Kailoni Cagey-Carter) and two grandsons (Teagan Bolstrom-Suggs and Allen Suggs).

As a council member I supported expanding key programs like Rediscovery, Paramedicine, reinstated code enforcement, maintained flat utility rates, provided \$790,000 in rental/mortgage and utility assistance to customers impacted financially by the pandemic. I supported efforts, saving the city of Port Angeles millions by refinancing water and wastewater bonds, supported suspending interest and late fees on utility accounts, and waived parking and business improvement area fees.

The next four years will require focus and stability to maintain a healthy City budget, support solutions to vexing issues and engaging leadership that strengthens our community partnerships, and work towards building new relationships. Areas of critical importance include affordable housing, homelessness, code updates, commercial district enhancement, build staffing capacity, building high-performing relationships, and working with partners to advocate for solutions that will help the childcare crisis. Childcare was in crisis mode prior to the pandemic. The vision is to move towards solutions that work for our community. Volunteers are being recruited for both the primary and general election. Volunteers who want to participate with coordinated door to door campaigning and literature drops, and follow-up with registered voters that have not voted can send me an email to vote4suggs@gmail.com . Donations are also being accepted for the primary election, in the amount of \$5, \$10, \$25, 50 dollars or what you can afford.

#### Letter to the Community-Jonathan J. Arakawa

Dear Lower Elwha Tribal Community,

Wow, what a year it has been for all of us! So much has happened since I last wrote to the community, I would not even know where to begin. Indian Country is in a time of reconciliation and reckoning. We are fortunate to now have an administration who is reaching out to Tribal Nations in the spirit of Tribal Consultation and strengthening our Nation-to-Nation relationship. Although we must lessen our reliance on the federal government, we cannot dismiss the trust and treaty obligation of the federal government which is constitutionally mandated.



I want to congratulate Anthony S. Charles and Steve J. Robideau on their reelection to the Business Committee. I also want to congratulate Frances G. Charles on being re-elected to another one-year term as Tribal Chairperson. Thank you to our Tribal Leaders for their representation and advocacy on behalf of the Strong People!

Personally, I continue to stay involved in our community. It is always an honor to serve. Our Shaker Church continues to answer calls to help our families and communities. We are readily available to help. Please contact me via cell at 360.565.6957 or via email at jonathan\_arakawa@outlook.com if you need help from the Shaker Church. As part of my job in the Port Angeles School District with the AmeriCorps Program, I have worked a lot in our schools, serving all Native students while ensuring they receive the most equitable and inclusive services and education they deserve. I am currently attending both, Peninsula College and The Evergreen State College, working towards both my Bachelor's Degree in Tribal Governance and my Masters in Teaching. It has been a wonderful experience and I have been able to bring those experiences back to our community in my work and advocacy—with the Strong People always in my mind while engaging and representing in all meetings and conferences.

Later this summer, I will be entering into my new job position with the Tribe as a Klallam Language Teacher with the Klallam Language Department. I am looking forward to working with the community as it relates to our language, history, and culture. We will do a lot of great things and it will be awesome to continue to engage all of our community!

Relating to service to the community... In February 2021, I was appointed to the Vice Presidency of the National Congress of American Indians (NCAI) Youth Commission. I am serving a two-year term. Since my appointment, we have met with the White House, our federal counterparts, and even representatives from the United Nations to speak on issues impacting native youth throughout Indian Country.

An issue I addressed to the White House and the Biden Administration, along with our sister National Native Youth Organizations, UNITY (United National Indian Tribal Youth, Inc.) and CNAY (Center for Native American Youth), was the need for an equitable and inclusive educational system for Native American students to ensure our students succeed in a system that was originally set up for us to fail. I stated, "Native American people are the fabric of this country. I grew up in a community who tirelessly advocated for our language and history to be taught in our local school district. I am the product and answer to those advocate's and my ancestors prayers--being able to academically experience my own rich and vibrant history and language in a classroom setting." I continued, "For far too long, our story has been pushed to the side and swept under the rug. We cannot full into the cracks of willingful forgetfulness. It is time to confront it." We sent a clear message to the White House on the issues impacting our constituents. The White House wants to convene in future meetings with all three of our National Native Youth Organizations. As it has been said before, this may be the first one, but it will not be the last. We will be excited to engage in the future.

#### **Diabetes Update:**

- Reducing your daily carbohydrate intake to 130 grams a day can greatly reduce your blood sugars. But not all carbs are created equal. You want to focus on the carbs that have >3 grams of fiber per serving.
- For the tribal patients that are on the Libre sensors, please call or text me when you need more.

#### Did you Know?

Cooking food in plastic containers or steaming bags may leach residues into your food while heating; use glass, metal or stainless steel.

#### Culinary Medicine:

We will discuss how to build your immune system to help your body prevent cancer. Cancer is a disease of our cells and a healthy immune system can help.

#### Some Common Causes of Cancer:

- Genetics
- Smoking
- Environment
- Unhealthy diet

#### Foods to Decrease:

- Sugar– especially soda. Limit to < 25 grams a day. Sugar increases weight which increases inflammation and can lead to cancer.
- 2. Exposure to chemicals.
- 3. Limit red meat intake and saturated fat.

#### Foods to Increase:

- Cruciferous vegetables (2 cups/week)- broccoli, cauliflower and bok choy.
- 2. Berries- 1-2 cups a week
- 3. Seafood-tuna, salmon, clams, oysters, halibut
- 4. Eat more fiber: grains, fruits and vegies.

#### Don't forget to schedule your diabetes quarterly.

Additionally, I called on the Biden Administration and the federal government for a federal mandate, through the U.S. Department of Education, on teaching Native American History in the United States public school system—utilizing the Native Knowledge 360 curriculum from the Smithsonian Institute: National Museum of the American Indian. I also asked for an unexpiring executive order on Tribal Consultation to properly execute curriculum development.

On June 3, 2021, we hosted the 2021 Lower Elwha Klallam Tribe-Johnson O'Malley Graduation Parade. We honored all Native graduates in our area. 10 students were able to show up and attend. We also honored our visionary leader and master teacher, Jamie Valadez, as she will be graduating to her well-deserved retirement. Jamie has always been a reliable force of strength and support; a groundbreaker who has put our Tribe on the map. I'm incredibly proud to report that we had 27 Native American students total graduate from high school this year in our community! Congratulations to the Class of 2021!!

At NCAI, we hosted our Annual Mid-Year Conference virtually, June 20-24, 2021. One of many speakers we heard from is U.S. Secretary of the Interior, Deb Haaland, the first-ever Native American person to be a Cabinet-level Secretary of any Administration. We also heard from other officials from the Biden Administration, including Secretaries from the Departments of Energy and Transportation, Ms. Granholm, and Mr. Buttigieg. Among the issues we experience in Indian Country, there will be discussions on Climate Change, FPIC – Free, Prior and Informed Consent (A.K.A., Tribal Consultation or Tribal Consent), Tribal Community and Economic Recovery, and much more. We will be received congressional updates from numerous members of Congress, including the federal delegation from the State of Alaska, Lisa Murkowski and Don Young; they said loud and clear that they support Tribal Sovereignty. Each of the secretaries and congressional representatives addressed the severity of climate change and the great need for Tribal Nations to be at the table, as the original stewards of our pristine lands.

During this conference, I attended a Climate Action Taskforce meeting with Northwest Tribal Leaders and leaders throughout the United States. I was asked to answer questions on behalf of the NCAI Youth Commission. One of the questions were what our thoughts are on how to engage tribal youth in the dialogues around climate change. I said that tribal leaders must first bring tribal youth to the table. We will begin attending meetings with the Treaty Council on the international level in dialogues around climate change, providing a tribal youth perspective alongside youth from Canada and other countries.

I feel like my updates could go on-and-on. I have always felt it was important to have the youth perspective shared and give the community an update on youth/educational sides of things. I will continue to stay involved here at home, locally, regionally, nationally, and internationally. Before I close my report for the months of work and advocacy, I want to take this moment to congratulate Jamie Valadez on her retirement. Jamie has dedicated over 30 years of service to our communities, preserving and revitalizing our Klallam Language, Culture, and History. 22 of those years at the Port Angeles High School. I said from the time Jamie announced her retirement that she is graduating to retirement. I raise my hands high in thanks and gratitude for her leadership, mentorship, and unwavering support. I said in my remarks to The Evergreen College, "Jamie is a reliable force of strength and support who further amplifies the strength of our ancestors that run through our veins."






