WITH THE THE TRIBE'S INITIALS AND WITH THE FISHER'S ID NUMBER. BUOY LINES WILL BE WEIGHTED TO KEEP THE

3. THE MINIMUM MESH SIZE FOR SHRIMP POTS AND RING NETS

MESH

ONE INCH, AS DEFINED IN REGULATION #S20-009.  
EXCEPT FOR FLEXIBLE (WEB) MESH POTS, FOR WHICH THE

THERE

MUST BE A MINIMUM OF 1 3/4 INCH STRETCH MEASURE.

TUNNELS

IS NO MINIMUM MESH SIZE FOR ENTRY TUNNELS, BUT

CAN ONLY BE LOCATED ON THE SIDES OF THE POTS.
