In the event the Puget Sound Treaty Tribes and the State of Washington reach agreement and the 2021-2022 Sea Urchin

Harvest Management Plan is completed before the end of this regulation term, this regulation will be superceded by a new regulation conforming to the provisions of the adopted harvest management plan.
