- 1. SHRIMP POTS: THE MAXIMUM TOTAL NUMBER OF POTS AND/OR RING NETS COMBINED PER FISHER PER VESSEL WILL BE 25 POTS. SHRIMP POTS REGISTERED TO A PARTICULAR VESSEL MUST BE SET AND PULLED BY THAT VESSEL, UNLESS OTHERWISE APPROVED BY THE FISHERIES OFFICE.
- 2. LONG LINES ARE ALLOWED IN THE HOOD CANAL SHRIMP FISHERY, PROVIDED THAT ALL LONG LINES AS WELL AS SINGLE POTS AND RING NETS SHALL HAVE BUOYS ATTACHED. BUOYS MAY BE ANY COLOR EXCEPT YELLOW OR ANY COMBINATION OF RED AND WHITE. BUOYS MUST REMAIN FLOATING AT ALL TIMES EXCEPT DURING EXTREME TIDES. BUOYS WILL ALSO BE MARKED WITH THE TRIBE'S INITIALS AND WITH THE FISHER'S ID NUMBER. BUOY LINES WILL BE WEIGHTED TO KEEP THE LINES FROM FLOATING. DURING THER FISHERY OPNING ALL POTS MUST BE REMOVED FROM WATER T AT 3:00 PM FRIDAY.
- 3. THE DAILY SUBSISTENCE HARVEST LIMIT IS 20 LBS PER FISHER.
- 4. ALL FISHERS MUST BE PREPARED TO HAUL OUT ANY REFUSE CREATED BY THEIR OWN ACTIONS DURING AND IMMEDIATELY AFTER THE FISHERY. REFUSE DISPOSAL FACILITIES MAY BE LIMITED IN CERTAIN AREAS OF HOOD CANAL.
- 5. ALL FISHERS MUST EITHER MAINTAIN HARVEST LOGS OR MUST PROVIDE CATCH REPORTS TO THE TRIBAL MONITORS AT THE

- LANDING SITES.CATCH RECORDS MUST BE REPORTED EACH TIME POTS ARE SET REGARDLESS OF WHETHER OR NOT SHRIMP ARE CAUGHT.
- 6. LOG SHEETS MUST BE DELIVERED TO EITHER THE FISHERIES OFFICE OR TO THE MONITOR. THE LOG SHEET INFORMATION MAY BE CALLED IN TO THE FISHERIES OFFICE BY 10:00 AM THE FOLLOWING DAY AFTER THE CLOSE OF THE FISHERY.
