OTHER RESTRICTIONS:

- 1) AS PER #F22-021.
- 2) RELEASE ALL OTHER SALMON UNHARMED.
- 3) THE HARVEST AREA IS LIMITED TO THE POOL BELOW THE QUILCENE HATCHERY OUTFALL AND SHALL BE MONITERED BY ENFORCEMENT OFFICERS.
- 4) ALL ACCESS IS RESTRICTED TO THE DESIGNATED TRAIL TO THE POOL AREA. ACCESS IS NOT PERMITTED TO THE ADJOINING BOULDER RIP-RAP AREA AND IS ALSO NOT ALLOWED TO THE HATCHERY OUTFALL CEMENT STRUCTURE.
- 5) FOR SAFETY CONCERNS ACCESS IS NOT PERMITTED ON THE ROCKS SITUATED ON THE NORTHERLY/WESTERLY SIDE OF THE RIVER BELOW THE FISH HATCHERY ROAD LEADING TO THE HATCHERY ITSELF AND SIDE OF THE RIVER THE HATCHERY IS LOCATED DUE TO THE INSTABILITY OF THE BOULDERS AND ROCKS.
- 6) PARKING AREA IS PROVIDED ON THE RIGHT SIDE OF HATCHERY ACCESS ROAD (NEAR BARBED-WIRE FENCE).
- 7) FISHERS ARE REMINDED THAT NO LITTER, FISH, OR FISH PARTS MAY BE LEFT BEHIND AFTER THE FISHERY CLOSES.
- 8) ALL CATCH MUST BE REPORTED ON FISH TICKETS OR ROADSIDE SALE REPORTING FORMS.
- 9) ALL CATCH MUST BE MADE AVAILABLE TO LOWER ELWHA FISHERIES STAFF OR QNFH STAFF FOR SAMPLING PURPOSES.
- 10) FISHERS ARE REMINDED THAT WHEN USING TREBLE HOOKS

TO BE AWARE OF SURROUNDING FISHERS, IN ORDER TO
REDUCE INCIDENTAL BODILY HARM.
