	The applicant/vendor must be an enrolled member of the LEKT Tribe who is twenty-one (21) years or older as of May 22nd, 2023			
☐ The applicant/vendor must have use of one of the following:				
	<ol> <li>A shipping container to be used as a firework retail space. The applicant/vendor is responsible for transportation of their container to and from the LEHC Log Yard. The shipping container must be sized 20ft x 8ft; with no exceptions; or</li> <li>A pop-up canopy tent to be used as a firework retail space that meets the following specifications:</li> </ol>			
		<ul> <li>Has 3 sidewalls</li> <li>Size 10 ft. x 15 ft., no exceptions</li> <li>White in color</li> <li>Is clean, intact (no large obvious rips, holes or broken poles), and remain in working condition for the firework season.</li> </ul>		
☐ The applicant/vendor must have the ability to pay in full the required fee and depon on May 31st, 2023 by 12pm. The fee is subject to increase to offset on-site costs.				
	1. A refundable damage deposit of \$300.00 must be paid in cash			

2. A non-refundable \$500.00 fee must be paid in cash to cover on-site expenses
