CATCH AREAS: DISTRICT 1, (SAN JUAN ISLANDS) MARINE FISH/SHELLFISH CATCH MANAGEMENT AREAS 20B, 22A, THAT PORTION OF 20A SOUTH AND WEST OF A LINE BETWEEN TOE POINT ON PATOS ISLAND AND POINT MIGLEY ON LUMMI ISLAND, THAT PORTION OF 21A SOUTH AND WEST OF LUMMI ISLAND AND A LINE RUNNING BETWEEN CARTER POINT ON LUMMI ISLAND AND THE NORTHERN TIP OF VENDOVI ISLAND, AND THAT PORTION OF 22B NORTH AND WEST OF A LINE BETWEEN CLARK POINT ON GUEMES ISLAND AND THE SOUTHERN TIP OF VENDOVI ISLAND, WEST OF GUEMES ISLAND AND SOUTH AND WEST OF A LINE RUNNING DUE SOUTH FROM KELLYS POINT ON GUEMES ISLAND. LEGAL GEAR:

1. HARVEST EQUIPMENT IS RESTRICTED TO INDIVIDUAL HARVEST BY HAND. DIVERS MAY HARVEST SEA CUCUMBERS USING SURFACE SUPPLIED AIR OR SCUBA.
2. ALL TRIBAL DIVERS AND DIVER VESSELS SHALL ADHERE TO OHS COMMERCIAL DIVING OPERATION STANDARDS.

CLOSED ZONES:

CUCUMBER HARVEST IS NOT ALLOWED WITHIN THE FOLLOWING RESEARCH/MANAGEMENT AREAS:

1. THOSE WATERS OF SAN JUAN CHANNEL AND UPRIGHT CHANNEL WITHIN THE FOLLOWING LINES: NORTH AND WEST OF A LINE FROM THE NORTHERN MOST POINT OF TURN ISLAND TO FLAT POINT ON LOPEZ ISLAND AND THENCE PROJECTED FROM FLAT POINT TRUE WEST TO SHAW ISLAND, NORTH OF A LINE PROJECTED FROM THE NORTHERNMOST POINT OF TURN ISLAND TRUE WEST TO SAN JUAN ISLAND, WEST OF A LINE FROM NECK POINT ON SHAW ISLAND TO STEEP POINT ON ORCAS ISLAND, AND SOUTH OF A LINE FROM STEEP POINT ON ORCAS ISLAND TO LIMESTONE POINT ON SAN JUAN ISLAND.
2. THOSE WATERS OF HARO STRAIT NORTH OF A LINE PROJECTED TRUE WEST FROM THE SOUTHERNMOST POINT OF CATTLE POINT ON SAN JUAN ISLAND TO THE INTERNATIONAL BORDER AND SOUTH OF A LINE PROJECTED DUE WEST FROM A POINT ONE-QUARTER MILE NORTH OF LIME KILN LIGHT ON SAN JUAN ISLAND TO THE INTERNATIONAL BORDER.
3. ARGYLE LAGOON: THOSE UNIVERSITY OF WASHINGTON-OWNED TIDELANDS AND ALL BEDLANDS ENCLOSED BY THE INNER SPIT OF ARGYLE LAGOON ON SANJUAN ISLAND.
4. THOSE WATERS WITHIN ONE-QUARTER MILE OF TATOOSH ISLAND AT 0.0 TIDE HEIGHT.
5. THOSE WATERS OF THE STRAIT OF JUAN DE FUCA IN THE VICINITY OF LOW POINT WEST OF A LINE PROJECTED TRUE NORTH FROM THE SHORELINE AT 123 DEGREES 48.3 MINUTES WEST LONGITUDE TO THE INTERNATIONAL BORDER, AND EAST OF A LINE PROJECTED TRUE NORTH FROM THE SHORELINE AT 123 DEGREES 52.7 MINUTES WEST LONGITUDE TO THE INTERNATIONAL BORDER.

OTHER RESTRICTIONS:

1. THE SUBSISTENCE DAILY CATCH LIMIT IS 25 SEA CUCUMBERS PER FISHER.
2. ALL COMMERCIAL HARVESTERS MUST REGISTER AT THEIR RESPECTIVE TRIBAL FISHERIES OFFICE PRIOR TO PARTICIPATING IN THE FISHERY.
3. IF PRODUCT IS UNHARVESTABLE FISHERS WILL STOP AND NOT FISH AS TO NOT TAKE QUOTA BEFORE PRODUCT READY.

CATCH REPORTING:

1. MUST TAKE A PHOTO OF HARVEST TICKET BY CELL PHONE AND SEND TO CHARLENE LAUDERBACK AT 360-912-2959 AT TIME OF SALE. AND SEND BY MAIL YOUR HARVEST TICKETS TO THE FISHERIES OFFICE WITHIN FIVE WORKING DAYS LOCATED AT 760 STRATTON RD PORT ANGELES WA.98363.
2. DAILY HARVEST INFORMATION MUST INCLUDE THE FOLLOWING INFORMATION:
  - a. DATE OF HARVEST

- b. VESSEL NAME OR BOAT REGISTRATION NUMBER
- c. LOCATION FISHED
- d. POUNDS LANDED
- e. AVERAGE DEPTH OF HARVEST
- f. NUMBER OF DIVERS
- g. TOTAL DIVER HOURS

- 3. ALL COMMERCIAL AND COMMERCIAL TAKE HOME CATCHES SHALL BE REPORTED ON TREATY INDIAN FISH RECEIVING TICKETS. ALL SUBSISTENCE HARVEST SHALL BE REPORTED ON SHELLFISH SUBSISTENCE CARDS. CARDS ARE AVAILABLE AT THE TRIBAL FISHERIES OFFICE.
- 4. LANDINGS MUST BE REPORTED AS "WHOLE UN-DRAINED" OR "SPLIT AND DRAINED." IF LANDINGS ARE "WHOLE UN-DRAINED", A CORRECTION FACTOR OF 0.5 MUST BE APPLIED TO THE HARVEST WEIGHT.
