HARVEST RESTRICTIONS:

- 1) AS STIPULATED IN REGULATION #S23-071, SECTION 6.
- 2) THE MINIMUM SIZE LIMITS FOR RED SEA URCHINS IS 3.25 INCHES, AND THE MAXIMUM SIZE LIMIT IS 5.0 INCHES, BOTH MEASUREMENTS EXCLUSIVE OF THE SPINES.
- 3) THE MINIMUM SIZE LIMIT FOR GREEN SEA URCHINS IS 2.25 INCHES EXCLUSIVE OF THE SPINES. THERE IS NO MAXIMUM SIZE LIMIT.
- 4) SEA URCHINS SHALL NOT BE TAKEN FROM WATER SHALLOWER THAN FIFTEEN FEET BELOW MEAN LOWER LOW WATER.
- 5) THE TWO VESSELS PARTICIPATING HAVE BEEN ASKED NOT TO GO OVER 1225 POUNDS AS TO NOT GO OVER OUR REMAINING QUOTA OF 2,567 IN DISTRICT D-4.

OTHER RESTRICTIONS: AS STIPULATED IN REG #S23-071, SECTION 7.

CLOSED AREAS: THOSE WATERS OF THE SAN JUAN ISLAND MARINE PRESERVES AND THOSE WATERS OF THE STRAIT OF JUAN DE FUCA IN THE VICINITY OF

LOW POINT, AS SPECIFIED IN REGULATION #S23-071, SECTION 4.

CATCH REPORTING: AS STIPULATED IN REG #S23-071, SECTIONS 9 AND 10. CATCHES MUST BE RECORDED IN HARVEST LOGS AND ON TREATY FISH RECEIVING TICKETS, PROVIDED THAT HARVESTERS MAY CALL CATCH INFORMATION INTO THE TRIBAL FISHERIES OFFICE IN LIEU OF MAINTAINING A HARVEST LOG.

JUSTIFICATION: HARVEST THE TREATY SHARE OF RED AND GREEN SEA URCHINS.
