The following regulation is promulgated by the Lower Elwha Treaty Council and shall govern the

conduct of off-reservation commercial and subsistence sea cucumber fisheries by the Lower Elwha Tribe in District 1, 2-1 and 2-2. The term of this regulation is

from August 1, 2024 through July 31, 2025, unless superceded, and is intended to regulate the sea

cucumber harvest by the \mbox{Tribe} in District 1, 2-1 and 2-2 under provisions

of Paragraph 4.6 of United States v. Washington, 898 F. supp. 1453 (W.D. Wash.1995), as amended by

the Stipulation and Order Amending Shellfish Implementation Plan, dated April 8, 2002, (hereafter

"Implementation Order"). In the event the Puget Sound Sea Cucumber Harvest Management Plan is

completed before the end of this regulation term, this regulation will be superceded by a new regulation

conforming to the provisions of the 2024-2025 Puget Sound Sea Cucumber Harvest Management Plan.
