EFFECTIVE DATES: MAY 1ST THROUGH SEPTEMBER 15, 2025
OR UNTIL QUOTA IS TAKEN

DAYS/HOURS: FOR THE LOWER ELWHA TRIBE THE FISHERY WILL
OPEN 6:00AM THURSDAY MAY 1ST, AND REMAINS
OPEN FROM SUNRISE TO SUNSET EACH DAY
THROUGH SEPTEMBER 15TH, 2025 OR UNTIL
THE TARGET HARVEST HAS BEEN TAKEN.

LEGAL GEAR: 1) THE MAXIMUM TOTAL NUMBER OF POTS AND/OR RING
NETS COMBINED IN THIS FISHERY WILL
BE 5 POTS PER FISHER.
2) LONG LINES ARE ALLOWED IN THE DISTRICT #1
SHRIMP FISHERY, PROVIDED THAT ALL LONG LINES
AS WELL AS SINGLE POTS AND RING NETS SHALL
HAVE BUOYS ATTACHED.
3) BUOYS MAY BE ANY COLOR EXCEPT YELLOW OR ANY
COMBINATION OF RED AND WHITE. BUOYS MUST REMAIN
FLOATING AT ALL TIMES EXCEPT DURING EXTREME TIDES.
BUOYS WILL ALSO BE MARKED WITH THE TRIBE'S
INITIALS AND WITH THE FISHER'S ID NUMBER. BUOY
LINES WILL BE WEIGHTED TO KEEP THE LINES FROM
FLOATING.

HARVEST REPORTING

- 1) AS PER REGULATION #S25-011
- 2) ALL SUBSISTENCE CATCHES SHALL BE
REPORTED ON TRIBAL SUBSISTENCE CARDS
AS SPECIFIED IN THE TRIBAL FISHERIES ORDINANCE.
- 3) THE TOTAL HARVEST WILL BE NO MORE THAN 667
PER TRIBE.
ONCE THIS LIMIT IS PROJECTED TO BE REACHED THE
FISHERY WILL CLOSE.
- 4) THE DAILY SUBSISTENCE LIMIT IS 20 POUNDS OF
SHRIMP PER FISHER.

HARVEST RESTRICTIONS:

- 1) THE ELWHA TRIBAL HARVEST FOR 25E AND THAT
PORTION OF AREA 25A WITHIN SHRIMP DISTRICT 1 IS 667

POUNDS FOR BOTH AREAS COMBINED.

JUSTIFICATION: COMMENCE SUBSISTENCE HARVEST OF THE TREATY SHARE OF SPOT SHRIMP.
